

Sheriff's safety plan to include emergency preparedness

During two of eight county-wide forums last March, the Śhasta County Sheriff's Office asked Burney and Fall River Valley residents for cost-effective suggestions to "build safer communities."

Those suggestions and the comments that came from 310 of the 1,000 surveys distributed were compiled into a Safety Plan presented to the Shasta County Board of Supervisors Tuesday.

The plan includes a proposal for community emergency preparedness and for a Community Safety Officer to reinvigorate Neighborhood Watch programs and help start Business Watch programs.

Sheriff's Department staff added their own ideas for better service and communication.

"We noted 30 recommendations from staff and citizens throughout

Shasta County and what's neat is that many of them don't require a lot of funding because it's volunteerbased," said Lt. Greg Wrigley, of Burney, who coordinated the local meetings.

The presentation to the supervisors is not a funding appeal, Wrigley said. "We're saying, here are 30 ideas. Do you support them?"

"The document is absolutely wonderful. It's a brilliant plan," said Lynn Miller, of Burney, one of eight community representatives on the Sheriff's Advisory Council.

"It's an impressive document as to content and scope and it is forward thinking and creative as to the community involvement and team concepts," she said.

Community Advisory Council member Susan David, of Fall River Mills, agreed.

"I think they've done a wonder-

ful job and the community will be greatly benefited if we can get some of these programs operating and if the community follows through," she said.

Miller is impressed with the detailed Community Emergency Preparedness Plan.

"It even covers what to do about pets and livestock if there's a disaster," she said.

She likes the idea of using citizen volunteers to fulfill President Bush's plan for a Citizen Corps.

"The Sheriff said they have 500 volunteers in Shasta County, including those in Citizens Patrol and Search and Rescue, and he doesn't feel they are being utilized to the extent they could be," Miller said.

An important ingredient of the Safety Plan from her point of view is the proposed Community Safety Officer, an appointed liaison between the Sheriff's Department and the community.

"That is really the cornerstone of the program," she said.

Communities want to keep the county's four School Resource Officers, positions that have been

Department of Parks and Recreation since the state first acquired the Horr Ranch in 1975," according to Roger Willmarth, acquisition planner for the DPR in Sacramento.

The state's current administrative easement with the Bureau of Indian Affairs is about to expire.

"We want a permanent easement," he said.

Currently, the only public access is by boat. While the state's "ultimate goal" is to provide better public access, that probably won't happen right away, Willmarth said.

Lava Creek Lodge, a general partnership, is interested in the sale, but still has to negotiate with three private property owners.

"We are not going to acquire the property until we have the access perfected between the county road (Island Road) and the property," Willmarth said.

Ahjumawi, which means, "Where the waters come together," was the word used by the band of Pit River Native Americans for their ancestral homeland, according to the DPR.

The waters which come together there are Big Lake, Tule River, Ja-She Creek, Lava Creek, and Fall River. Together they form one of the largest systems of fresh water springs in the country.

"Brilliant aqua bays and tree studded islets only a few yards long dot the shoreline of Ja-She Creek, Crystal Springs, and Horr Pond.

"Of the park's 6,000 acres, over two thirds of the area is covered by lava flows from 3,000 to 5,000 years ago, including vast areas of jagged black basalt," according to California DPR.

There is minimal development in the park and only three environmental campsites.

DPR is accepting written comments for the record if received by Aug. 14, 2002.

Local students battling flames

When one of the first and biggest fires of the summer broke out in eastern Arizona, firefighters from the Lassen National Forest, Hat Creek Ranger District, were on the scene to help tame the 468,638acre blaze.

"We got there right when it started blowing up," said Billy Schmierer, 20, of Burney, who has a summer job as a firefighter for the U.S. Forest Service.

During the past three months the Hat Creek Ranger District has sent its 60 firefighters and six engines to fires in Colorado, Arizona, New Mexico, Utah, Oregon and all over California, said Fire Management Chief John Stauffer.

"We've had people all over the place," he said.

On Monday, Schmierer, a junior at the University of California, Davis, and Scott Turner, a June graduate of Fall River High School, were sent to fight the Sour Biscuit Fire, burning southwest of Cave Junction, on the Siskiyou National Forest.

"We've also got people on Post and are sent out on the line, the McNalley Fire now," he said, referring to the fire in the Sequoia National Forest that has already consumed 98,000 acres and on Monday was 55 percent contained.

Stauffer said seven firefighters are assigned to an "engine module," with five personnel on duty seven days a week.

When there's a fire, the five on duty are the ones who get to go.

Schmierer said his was the second group from the Hat Creek station sent to Arizona's Chediski-Rodeo Fire.

Still finishing his semester at college, he missed going with Engine 34, where he's assigned with Capt. John Hubbard of Fall River, Engineer Doug Howarth of Hat Creek, Apprentice Billy Covert of Burney, Assistant Engineer Nelson Dodds of Burney, Senior Firefighter Pat Howard of Montague, and Turner.

"I left a week and a half after they did with Engine 33," he said.

As soon as crews arrive, they check in at an Incident Command



partially funded through three-year grants due to end in October.

Deputy Joe Gonzalez serves the Fall River JUSD, which has proposed funding half the position if the county will pick up half.

The Safety Plan includes departmental issues.

Deputies want "consistent in-house training in short blocks of instruction" covering self-defense, baton use, arrest techniques, and building searches.

'Training is either nonexistent or sporadic at best," they said. "Deputies feel the lack of training puts them at risk." It also puts the department at risk of being vicariously liable.

Deputies asked for a review of beat boundaries to even the workload and they want a staff accountability plan.

The lack of sufficient manpower is always an issue and so is funding.

"We need more deputies," said David.

Patrol staffing has increased by 4.8 percent in the past 10 years, while the population in Shasta County has steadily increased, from about 156,000 in 1992 to 166,000 people today. The department had 42 sworn patrol staff in 1992, 40 in 1995-1996, 45 in 1996-1998, 46 in 2000-2001 and is now back to 44 people covering 3,850 square miles, according to the report. Calls for services increased 27 percent during the same time period.

using retirees and civilian employees, juggling a few positions, and maintaining a pool of field-trained employees ready to transfer into vacant positions.

Miller applauds the Patrol Team's recommendation to use a dictation system so that deputies aren't spending time typing up reports in the station house.

"I want these guys driving around, not typing," she said. "We're not paying them to type."

She appreciates that the Sheriff's Department reached out to the community.

"Even though there was total apathy from the community, they (the Sheriff's Office) went through with it and produced a great document," Miller said.

David, who is a Citizen's Patrol volunteer and a member of the Fall River Vallev Chamber of Commerce, has renewed hope.

"Eastern Shasta County is forgotten and it was nice to be included. We need to get more involved and I think this will bring the community closer."

Sheriff Jim Pope said the community safety plan is not an "exhaustive analysis" but a "snapshot of community feedback regarding (patrol) services and safety.

The work is not done, he said. The next phase is implementing, monitoring, and modifying the plan.





Another factor is Shasta County's tight housing market, which forces families to spend more money on rent, leaving less for the food budget.

Several food sources were benefited by this food drive including St. Francis of Assisi Catholic Church Food Bank in Burney, Tri-County Community Network Voucher Program, and the Community Food Pantry, which is supported by seven Fall River Valley churches.

Court date scheduled for former J.P. radiator shop If convicted, the Sellars

The former owners of a Johnson Park radiator shop have been ordered to appear for trial in January in Shasta County Superior Court on charges resulting from a complaint filed by the California Department of Toxic Substances Control.

The complaint was filed against David Sellars and Marvin Sellars, co-owners of Sellers Bros. Radiator Service, in February 2002 for disposing hazardous waste at their business and for allowing unsafe and unhealthy conditions to exist at the shop.


business Their was inspected in 1999 and the charges because the Sellars reportedly failed to clean up toxic waste that had drained into the ground from a dumping pile, according to Deputy District Attorney Larry Allen.

He said they disposed of sandblast material next to the shop and it contained levels of copper, lead and zinc.

Legally, a certified hazardous waste disposal company must haul off the material and provide records.

The July 27, 1999 site inspection was a routine inspection of 27 radiator shops in three counties, Allen said. Six businesses were subsequently referred to the District Attorney and all but two were resolved.

In an interview in February, David Sellars said, "Bureaucracy has singled us out," and described their efforts to clean up the business that



recovery of costs, including the expense of the investigation and prosecution.

they had run for eight years.

Sellars said the previous owner, Walt Rainey, had a radiator shop at the site for 20 years and "a heck of a (sandblast) pile" that they shoveled up and put into barrels to be hauled off at a cost of \$300 per barrel.

They also purchased, but did not install, a \$5,900 water waste treatment system.

As he closed down his business in February, Sellars said the lawsuit had "pushed us over the edge financially" and that they couldn't afford to do more clean up.
