Fire department to charge for inspections, agrees to write off \$59,000 in bad debt

The Burney Fire Commissioners agreed at their July 9 meeting to write off almost \$59,000 in bad debts and to adopt an overall cost recovery fee schedule as Fire Chief Bob May continues to streamline the Burney Fire Protection District and tie up its loose ends.

The commissioners discussed

creating a Fee and Charges Ordinance since the department only charges for ambulance service.

Such an ordinance would recover user fees for non-tax supported services, May said.

This would include charging fees for uniform fire code permits, hazardous materials permits and inspections, fire suppression and

emergency services, certain state-regulated occupancy inspections, and new construction plan reviews and inspections, among other services the department currently provides at no cost.

May said that under California law, parade floats should be inspected for safety, as well as "assemblies of people in a confined

space" such as the fire department's annual Haunted House.

"These are public safety issues that we have to comply with," he said.

Commissioner Donna Caldwell suggested that they permit non-profit organizations without requiring a fee.

"We could require them to be

safe, but we don't have to charge a fee," she said.

Based on Shasta County's current fee schedule, the Burney Fire Department could have collected almost \$2,000 for the 20 local residential and commercial Fire and Life Safety Approvals it did during a seven-month period.

Fire lookouts to remain open this season

The Lassen National Forest has been successful in staffing the Solider Mountain Fire Lookout in Glenburn so that it remains open this summer.

Until this summer, the California Department of Forestry and Fire Protection staffed Soldier Mountain, which was one of four fire lookouts in Shasta County and 22 statewide that the state planned to close in order to trim its budget.

In April, The Intermountain News reported the state said it could save

\$750,000 by closing all CDF lookouts this season.

Battalion Chief Tim McCammon of the CDF station in Johnson Park said it costs about \$34,000 to staff a CDF lookout for the five-month season.

The federally funded U.S. Forest Service lookouts, including Burney Mountain and West Prospect Peak, were slated to remain open and the Lassen National Forest wanted to help its neighbor.

Closing Soldier Mountain "would

have left the Intermountain community without a very important resource for quick fire spotting in our backyard," said Leona Rodreick, public affairs specialist with the Lassen National Forest in Susanville.

"This was identified as a great opportunity to work together to form a cooperative partnership," she said.

The Lassen and the Shasta-Trinity Unit of CDF met to discuss the

Local posts on boards up for election

The four-year terms on several governing boards in the Intermountain area are expiring and there will be a consolidated general election in Shasta County on Nov. 4 to fill the positions.

No elections are scheduled for Modoc and Lassen counties unless there is a recall election on Gov. Gray Davis.

Three local school boards each have openings for two four-year terms.

In Fall River Joint Unified School District the elected incumbents are Dr. Robert Hatcher and Nancy Sisk.

In the Mountain Union School District the seats are currently held by elected incumbent Bob Byrd and appointed incumbent Teresa Ann Robbins.

In the Indian Springs School District the openings are for the seats held by elected incumbents Paul D'Amico and Douglas Wakefield.

There are two four-year terms opening in the Burney Fire Protection District. The elected incumbents are Donna Sylvester and Ann Walker.

In the McArthur Volunteer Fire Department, the terms of elected incumbents Hiram Brown and Lawrence Agee are expiring.

The Fall River Mills Fire Protection District has three four-year terms opening. The elected incumbents are Richard Hall, Kathy Ontano and Harold Bassett.

The Fall River Mills Community Services District has two four-year terms opening, with the expiration of the terms of elected incumbent Jim Halverson and appointed incumbent Terrence O'Neill.

The Burney Water District has two four-year terms that are opening and are currently held by elected incumbent Jackwelyn Young and

Expect delays for 2 highway projects here

Two road maintenance projects on Highway 299 are causing traffic delays.

Anticipate up to 16-minute delays on portions of Highway 299 from Four Corners (at Highway 89) to Fall River Mills while Caltrans completes a striping and recessed marker installation.

Expect delays of up to 10 minutes on Highway 299 three miles east of Montgomery Creek to six miles west of Burney.

Caltrans updates its road information each Friday for the following week and could not say how long each project would continue.

"It's a drain on our general fund not to charge a fee for our services," May said.

He suggested that they base their fee schedule on the countywide Consumer Price Index, which could be reviewed annually and adjusted.

In other financial business, May said that both of the department's outside collection agencies recommended that they write off the old accounts.

"We've exhausted our ability to collect on these and our auditors are harping that we need to clean up our account receivables," May said.

One collection agency,

Sierra Receivable, Inc. (SRI), recommended writing off 50 accounts totaling \$33,465, while leaving \$41,955 in active status.

The district transferred another 95 backlog accounts to an ambulance billing service, AIS, Inc., and they have recommended writing off 39 accounts totaling \$25,469. AIS would still seek to recover a remaining \$52,632 in debt.

May noted that by the time outstanding bills go to a collection agency "the chances are little to none" that the debt will be paid.

He said many of the accounts are several years old and in some cases the debtor is deceased, has

moved out of the area, or has claimed bankruptcy.

However, May said, credit reporting systems keep the information on file and if the debtor attempts to buy a large item, such as a home or car, the amount past due appears on their credit check and must first be paid in full.

In other business, the Commissioners:

-Designated Lynn Miller and May as voting directors on the board of their insurer, the California Joint Powers Association, which meets July 23 in Orange County and provides up \$375 for travel, meals and lodging;

-Directed Chief May to follow the auditor's recommendation and consider a

contract with a local accounting firm to provide combined payroll and accounting services at \$1,860 per year;

-Agreed to renew the district's Blue Shield health insurance coverage for three full-time employees with a \$250 deductible and to include vision coverage;

-Met in closed session and took "no reportable action" on a potential litigation case.

According to the Lassen County News, 146 employees at High Desert State Prison in Susanville received notices that they could lose their jobs in November.

The "surplus notices" went out to 104 correctional officers, six captains, five lieutenants, and nine sergeants, as well as supervisors, an associate warden, 19 vocational education instructors and two vocational education supervisors.

The prison employs 1,246 custody and support services staff.

The California Department of Corrections sent surplus notices to more than 2,300 of its 49,000 employees statewide.

Wrongful death suit filed against doctor, hospital

A Big Valley resident has filed a \$1 million wrongful death lawsuit against Mayers Memorial Hospital and Fall River Mills physician Dr. Chris Camarata.

The surviving family of Kenneth "Hoss" Salters - his widow Lori Salters and their children - claim that when Salters was taken to the Mayers' emergency room on July 17, 2002 for treatment "the care provided by Dr. Camarata failed to meet the standard practice of care," according to Sacramento attorney Bill Callaham of Dreyer, Babich, Buccola and Callaham.

Salters went to the ER after driving a nail from a nail gun into his left foot.

As part of the treatment he was given morphine for his pain.

He returned home and died the following morning as a result of what Callaham said was a "significant overdose of morphine."

After almost six months of investigations and delays, the Shasta County Coroner's Office released its cause of death as respiratory insufficiency due to a pulmonary edema, a result of multiple pulmonary emboli (blood clots) in the lungs.

According to documentation from the state Department of Health Services, Salters received 10 mgs of morphine sulfate seven times between 7:27 p.m. and 8:30 p.m. while in Mayers ER.

"It's a matter of record that he was given 70 mg of morphine (intravenously) over a period of 63 minutes and we believe no reputable emergency physician would

prescribe that amount of morphine in that amount of time under those circumstances," Callaham said.

The state's documentation was in their findings after a complaint was filed Nov. 1, 2002 on issues related to the Salters case.

The state initiated an investigation Jan. 7, 2003 and wrote Mayers up on four deficiencies that included having poor ER documentation and poor communication between the physician and his staff.

The state also found failure to monitor and properly document ER procedures.

Bob Kennard, district administrator for the Department of Health Service's Licensing and Certification program said in April that Mayers had provided a plan of correction and for the state's part "the cycle was complete."

Callaham said the single lawsuit names both Camarata and the hospital.

He said that while hospitals are often not deemed responsible for the actions of physicians on their staff, "We believe the standard of care was also breached by nurses who should have questioned (their instruction) and the hospital for not having policies and procedures in place for preventing this."

Mayers CEO Jerry Fikes and Dr. Camarata had no comment.

The Salters family is seeking approximately \$700,000 for economic loss, a figure that includes the estimated loss of Hoss Salter's earning capacity, and the \$250,000

allowed maximum for non-economic loss, which pertains to the loss of a husband and father.

Callaham said both the hospital and Dr. Camarata were served in mid-April and that he hopes to begin depositions later this month.

Redding attorney Steven Enochian of Enochian and Kennedy is representing Dr. Camarata but was out of town and not available for comment.

Although Hoss Salters died July 18, 2002, the verdict of death was not signed off until Dec. 4, 2002 and even then the cause of death had not yet been officially determined.

Changes in personnel in the Shasta County Coroner's Office may have been a cause for the delay.

When asked in November 2002 for the cause of Salter's death, Chief Deputy Coroner Ray Bailey said the case had been referred to the state medical board.

A week later, Bailey had retired and was replaced by Capt. Harry Bishop, who said the case was under investigation by a forensic pathologist.

The pathologist, Dr. Dan Purtzer, was contacted several times for comment about the cause of death, but was not available and did not return the phone calls.

In December, Bailey had returned to the Coroner's Office to fill in for Bishop, who was on leave after emergency surgery.

On Jan. 10, 2003 Bishop was back in his office and released the official determination.

possibility of staffing Soldier Mountain with Lassen personnel and the two agencies wrote a Memorandum of Understanding that allows Forest Service personnel to staff the CDF lookout.

The MOU can be extended if the need still exists next year, Rodreick said.

"Not only do our agencies benefit from this great partnership, but the people who live in the Intermountain Area benefit as well. This is a win-win situation," said John Stauffer, fire management officer for the Lassen's Hat Creek Ranger District.

In a related issue, the Lassen National Forest also worked with the Tehama-Glenn unit of CDF to discuss staffing the Inskip lookout near Paynes Creek with Lassen personnel to make up for the loss of the Turner Mountain lookout

Turner Mountain on the Lassen National Forest was condemned because of health and safety issues related to the structure, including its unstable foundation, lead-based paint, asbestos and rats.

"We're planning to replace the lookout eventually, but until that happens there was a need to provide lookout coverage to assist with detection of fires," Rodreick said.

The two agencies wrote another MOU to allow Forest Service personnel to staff the Inskip lookout up to five years, with an extension if needed.

Both the Inskip and Soldier Mountain lookouts opened in June and will be staffed by Forest Service personnel through fire season.

The Burney Mountain and West Prospect Fire Lookouts opened as usual this season with Lassen staff.

These two lookouts are

also an important resource as they provide lookout coverage for the Hat Creek Valley, Hat Creek Rim, Burney, and Lassen Volcanic National Park, Rodreick said.

Entrance exam for high school students delayed

The state Board of Education unanimously voted July 9 to delay the California High School Exit Exam as a requirement of graduation for two years.

This action means students in the class is 2004 and 2005 are no longer required to pass the exit exam as a condition of earning a high school diploma.

Instead, the state said the Class of 2006 would be the first class to face the requirement.

The state delayed the exit exam in the wake of recent independent external evaluation that found that many stu-

dent, for different reasons, "may not have benefited from courses of initial and remedial instruction to master the required standards."

State Board President Reed Hastings said the exit exam would continue to be a "catalyst for raising standards."

He said the exam is "here to stay. It will remain in place as an important gauge of student achievement and as a means of identifying and eradicating student disparities."

The law does not allow the state board to delay the exit exam again, he said.

Former bank teller sentenced to 120 days

A former Burney bank teller was sentenced June 24 to 120 days in Shasta County Jail after pleading guilty to embezzlement from Tri Counties Bank.

Fonda Ray, 24, was also fined \$580 and ordered to serve 36 months on court probation upon her release from jail. She was given credit for one day already served.

Shasta County Superior Court Judge Karen Jahr dismissed a charge of grand theft of personal property,

two counts of forgery, and one count of petty theft.

Ray had been working at the Burney branch for about two months when the bank reported a possible theft Dec. 31, 2002.

According to Shasta County Detective Anthony Bertain, Ray had a customer's credit card convenience checks that she made out and cashed, depositing \$20 into the client's account and keeping more than \$4,000 for herself.

Local law enforcement to target bicycle violations

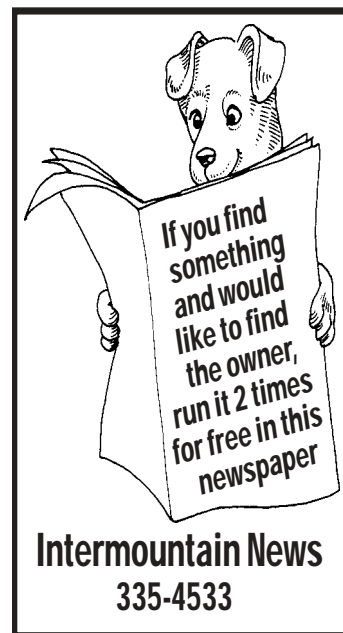
As a result of a local 2003 survey in Shasta County, by the Injury Prevention Coalition of Shasta County, California Highway Patrol and Redding Police Department officers will increase patrols to watch for children riding bicycles.

The survey resulted in a total of 202 observations of children riding bicycles, skateboards, roller/in-line skates or non-motorized scooters. Overall, sixty-nine percent did not wear a helmet.

The Office of Traffic Safety (OTS) is funding the coalition, who in turn has contracted with the two law enforcement agencies to provide specific bicycle enforcement.

Enforcement begins now and runs through the first week of August. The goal is to reduce the number of bicycle traffic related collisions and injuries on county roadways.

Enforcement will focus on vehicle code related violations with emphasis on helmet usage. The primary focus will be on children ages

Shasta Mist line of bath, body products produced in Pittville home

Soap, lotion, lip balm, bath oil, massage oil, bath bomb, foot crème, foot scrub, body butter...

It might seem like Bath and Body Works, but it's actually Kathy McAlerney's kitchen, the production headquarters of Shasta Mist bath and body products.

Kathy McAlerney and David Perkins, both Pittville residents, are the Intermountain area's producers of bath and body products and they continually apply their innovation in creating new soaps and lotions under the Shasta Mist name (formerly David & Kathy's).

Their enterprise began several years ago when they took their first soap-making class at Shasta College, and since then it's continued to grow.

"I haven't bought a bar of soap in six years," Perkins said.

And why should he, when he can just make one.

After their initial learning period, McAlerney and Perkins got busy with their own recipes and have since designed many lotions, soaps, and creams.

They use books for guidance but always end up creating new recipes on their own.

They say their most popular are the vanilla and peppermint products.

Some of their fragrances are bought from out-of-town suppliers, but the peppermint comes from the local mint crops of the Fall River Valley, and lavender from McAlerney's own garden is also used.

McAlerney said they also stumbled upon a designer scent.

Forest Morning happens to smell exactly like the cologne Drakkar Noir, she said. It's a staple of their fragrance library, but most titles are in rotation and constantly changing.

In addition, they make unscented products for those with sensitive skin.

Since they are both busy in their careers, McAlerney and Perkins have had to limit their sales.

They've found it best to sell their products in arenas

where they can reach the largest customer base.

They are now fixtures at Santa's Workshop, the annual artisan fair held at the Intermountain Fairgrounds the first weekend in December.

Production begins in October and runs full time leading up to the event.

"We can't make it too far ahead of time because we don't have preservatives," Perkins said.

Last year, they made about 500 bars of soap, along with their other products and nearly sold out.

Santa's Workshop is the best spot to get their products, they said, but that doesn't stop family members from putting in their orders year round.

When McAlerney visits her family in Monterey, they don't even want to see her unless she's accompanied by Shasta Mist products.

"They just want my soap," she said.

Last year, she and Perkins made 17 batches of soap.

"It takes so much time, but we have so much fun doing it," McAlerney said.

The soap making process is complex and takes much preparation.

McAlerney and Perkins produce two types of soap, tallow based and vegetable based. Tallow soap is far superior they say, and their favorite to make.

The process starts with a trip to the butcher, where they get animal fat that is then rendered in McAlerney's kitchen. After much straining, the tallow is ready for use.

The next step in the process is adding additional oils to the tallow, including olive, apricot, and coconut oils.

The oils are all cooked together while lye and water are mixed.

The lye and water mixture and the oil mixture are raised to the same temperature of somewhere between 98 and 102 degrees.

They are then combined and mixed by hand from anywhere from 20 minutes to two hours until there is a trace, that is until the mixture is sufficiently gelled and consistent.

It's then time to add the

essential oils which lend fragrance to their formulas.

Perkins said that it can be difficult to find fragrances they like consistently.

Their suppliers are constantly changing because fragrances are constantly changing. They might get a good fragrance one time, but on the next order the same fragrance in name can actually smell quite different.

When the soap has been mixed, it's time to put it in molds where it will remain wrapped in a wool blanket for 24 hours, as it needs to stay warm during this period, and then for three weeks it cures while the ingredients become pH balanced.

This part of the process is important because lye that isn't pH balanced can burn the skin.

When it's done curing in the molds, it's time for the soap to be hand-sliced into bars.

These then cure for several more weeks. Then it's ready for the final hand-wrapping process.

It can be difficult using a kitchen as a soap factory, they said.

Everything needs its own container and they have to hand wash all of their utensils, or risk contaminating everything.

McAlerney described the mistake they made one time, in putting a measuring cup in the dishwasher that had previously held lemon-grass essential oil.

To this day, she said, her dishes smell like lemon-grass.

But mistakes are part of the game and though they've only had one soap batch not work out, some of their other products have not been as successful.

Lip balm was a real adventure, they said.

McAlerney described the time when they put too much beeswax into the mix and the balm ended up rock hard and unusable.

Cosmetic glitter in their lip balms has also been tricky, they said.

On their first batch, they added too much glitter and it ended up settling on the bottom of the individual balm pots.

The top appeared normal, Perkins said, but towards the bottom was a thick glitter balm.

He absent-mindedly applied lip balm one time, not realizing that he had glitter gloss, and ended up with what he called "disco lips."

So, apparently their products can be good for a costume party, but there are also some more practical uses.

The soap can be used as shampoo, shaving cream, and facial cleanser.

And they've also created an oil that can be used for under-eye repair.

McAlerney and Perkins would like to eventually expand their market.

"It would be nice to be able to sell somewhere in town," McAlerney said. "We'd have to retire though."

Until then, they will continue their innovative style as they look forward to creating shampoos, conditioners, and sun protecting moisturizer.

Intermountain Preschool teacher, administrator leaving after 14 years

The Intermountain Preschool is saying goodbye to its longtime teacher and administrator, Lillian Arnold.

The McArthur co-op preschool has been home to Arnold since 1989 when she and the school's board of directors began the complicated process of putting together a school for the first time.

Now, Arnold's first class of students is graduating from high school, and on June 6 it was her turn to graduate from her leadership post.

When Arnold began her job, the school was still in formation.

For six months, she and the board worked to get licenses and find a home for the school.

When the work was completed, it was time for the Intermountain Preschool to open in its new home at the Intermountain Fairgrounds, and the school began instruction in the spring of 1990.

This was not Arnold's first experience working with children.

After getting a bachelor's degree in language pathologies and a master's in special education, Arnold began work in early childhood education.

She started as an infant-learning specialist and was soon a daycare coordinator.

Finding the job at the Intermountain Preschool came by chance, she said.

She saw the ad in the newspaper, applied, and got the job.

In her position, Arnold not only teaches, she also works with the board in an advisory position updating the members on new laws and curriculum changes.

In addition, she helps with the business end of the school, keeping financial records and organizing fundraisers.

Arnold has seen the school go through many changes over the years. When she was starting out 13 years ago, preschool was primarily a social activity and functioned as a playgroup for children.

Now, preschool is a vital preparation tool for kindergarten, she said.

Incorporating academics into the preschool structure has been a challenge, Arnold said. Because of this requirement, she has had to adapt the program so that the needs of all age groups are met.

The school generally

accepts children from ages 3 to 5 and currently has 25 students.

This is half of what the school used to have, she said.

With the entrance of Head Start into the Big Valley and McArthur areas, enrollment has dropped significantly.

But Arnold says that regardless of numbers, the children have been a joy to work with. "The kids are just great," she says. "It's always a surprise."

Arnold will most miss the wonder that children have and the questions they ask.

She described one day in particular, when one little girl ran up to her and said, "Teacher, why won't those boys do what I want them to do?"

Though she might not have the perfect answer, it's moments like these that have kept her job interesting, she said.

But besides the kids, the parents have also been an important part of her experience at the preschool.

Arnold said the most important thing she's learned is that parents really do care about their children.

"Parents are totally interested in their children, totally

gung-ho," she said. "They're not failing in their children's upbringing. Parents bend over backwards to make their children's educational life a success."

Despite all the positive experiences Arnold has had, it's now time for her to go.

"This was just a great job to have while my kids were in school, but now that they're older, I want to work with families in a different capacity," she said.

Before she moves on, Arnold is spending some time working with the Intermountain Preschool's new teacher, Lori Salters.

"She's fantastic," says Arnold. "I think she'll just be great."

Salters has worked with children for many years and looks forward to the experience.

"What's been neat for me is to see how enthusiastic the parents are," says Salters. "I'm looking forward to working with the kids."

Salters will officially begin her position at the preschool when school starts again next fall.

And though Arnold says she will miss the children, she is looking forward to the new opportunities ahead.

'Still long way to go' son writes in letter from Iraq

Sgt. Liam Diezsi, a Burney High School graduate, ate his first cheeseburger since being sent with his military unit to the Middle East in January - and it was worth writing home about.

"I was so happy. It was the first time that I didn't have to pull my food out of a brown MRE bag in five months!"

"I have to tell you it's the little things that we take for granted," he wrote in an e-mail to his parent, Burney High School teachers John and Cindy

Diezsi.

Sgt. Diezsi is stationed with the 130th Engineering Brigade/54th Engineering Battalion in Bamberg, Germany.

His unit was sent to Kuwait at the end of January to "secure and control Baghdad."

The Diezsi family received the following letter from their son, written April 13 after his brigade left Kuwait for the march on Baghdad.

(In it he refers to his sister Angela and son Liam)

Dear Mom and Dad,

Greetings from the land of sand! I am alive and well. I'm sorry that I didn't write to you sooner, but the supply lines this far north just opened and this is the first opportunity we've had to send mail.

I did receive a couple of letters prior to crossing the border, but nothing since.

I have gotten two boxes and a few letters from Angela and Liam though. I enjoy reading the letters from Liam. I miss him so much and I pray every day that he is kept safely in Angela's care until he comes back to me.

All I can say about the desert right now is the same thing that Robin Williams said in 'Good Morning Vietnam' - it's hot. . . d--- hot! I manage to find some shade every now and again though.

The battle is coming to an end. There has still been no 'cease fire' called, but our mission is complete.

We were to secure and control Baghdad and now that the fighting has pushed north, we have remained here, in the desert.

I don't think that we will be here much longer. The units that fight the war generally do not stay to keep the peace. That is a contradictory mission. I am thinking that we should all be safely back in Germany by June or July. We will see.

My soldiers are also holding up well. We found ourselves in some tight spots, but because of their discipline and trust in the decisions of their leadership, they were all brought safely through those times.

Even the youngest soldiers who have not ever had to react under fire have done extremely well.

It saddens me to have to be a part of such destruction, but the rewards come when I see the faces of the people as they see the reality of their freedom come to life. I cannot begin to describe the way it makes me feel. It almost balances everything.

Well, just know that I am doing well and that I am safe. No harm will come to me, Mom and Dad. I am out of harm's way for now. Maybe when we can talk again, I can explain things better.

I love you both and will write again soon.

P.S. Keep the yellow ribbons up, for all of us.

The Diezsi's last heard from their son about two weeks ago, when he was still around Baghdad.

They said they don't often hear from him, but did share some highlights from his more recent e-mails:

"Temps in the 120's plus, with the wind picking up in the afternoons to provide a 'nice coating over the sweat.'

"The soldiers still have to put their necks out there every day, so I don't think that things are complete quite yet."

"I wanted to let you know that I got to eat a cheeseburger the other day..."

"I got to go on a mission to the airport and the military had just opened a makeshift Burger King in a trailer there."

"They only sold a few items, but I hope to get more so that I can put the 12 pounds that I have lost back on."

"Please let everyone know that I am doing okay and that aside from some cuts, bruises and hurt morale, my soldiers are hanging in there."

"I don't care what the news says about the war being over, because from the looks of it around here, we still have a long way to go."

The Diezsi's said they still have not heard when Liam and his soldiers will be returned to Germany.

Their commander was hoping to get those who had been deployed to Kosovo last year, and he was, home before the others.

"Liam had thought originally he'd be home by the end of this month, but now the thought is anytime

between September and March," they said.

Another glimpse at life for the soldiers was written by Jayme Loppnow, public affairs officer for the 130th Engineer Brigade:

"Life is getting a little bit easier for soldiers of the 130th Engineer Brigade stationed in Balad, Iraq."

"Individual air conditioning units were recently installed in workplaces and sleeping areas, a 'washateria' with automatic washing machines was installed, and a personal hygiene station was just completed."

"These may not seem like major improvements to some back home, but for soldiers living in 110-degree heat, hand washing laundry in plastic bins and brushing their teeth outside using bottled water, the developments make life just a little more bearable in the extremely hot, dry climate."

"When the 130th Engineer Brigade arrived in April there was absolutely no running water. How did we bathe? We had two choices - take baby wipe showers or use the bottled water," said one soldier.

"Other recent improvements include new light fixtures, a large generator for electricity, electrical wiring, makeshift outhouses, and both interior and exterior doors."

"When the 4th Infantry Division seized the airfield in April, the 17-square-kilometer base was virtually unusable because of strewn garbage and the lack of plumbing and electricity because of looting," a soldier said. "The garbage was waist high and the buildings were just shells."

New coordinator for Refuge in Burney was trained by daughter

When Sheridan Hart, the Intermountain Area coordinator for the Shasta County Women's Refuge, resigned in June to be married, she found a compatible replacement - her mother.

Dottie Hart already had on-the-job experience as a volunteer and had completed the advocacy training.

"I was very delighted when they chose me," she said.

The Women's Refuge and its volunteers provide 24-hour crisis intervention for victims of domestic violence and sexual assault and offers emergency shelter.

"People forget we're here unless something happens to their wife, sister, daughter or another relative or friends," Hart said.

But assistance is available 24/7. "You can always get to us," she said.

"I also want to remind the public that we have a lot of special people here who use their volunteer hours to help others in the community," she said.

The office in Burney is open weekdays from 8 a.m. to 5 p.m. and the toll-free Crisis Line is available from 5 p.m. to 8 a.m. weekdays and around the clock on weekends.

The SCWR also offers counseling, safe housing in Redding if necessary, and temporary restraining orders.

For those with critical and

ongoing problems, SCWR provides long-term transitional housing with furnishings, childcare, meals, and career training.

"We can really help set people on their feet again," she said.

Confidentiality "is our number one rule. No one needs to have worries about that."

In addition to providing assistance and intervention, Hart has come to the SCWR in financially troubled times and is spending much of her time raising funds to keep the shelter in place.

"Our funding has been substantially cut and we can't afford to hire an assistant here and we are looking for another office."

"It's very said that we have to move," she said, about their existing facility, an inviting home protected by trees off Highway 299.

Hart said they need at least \$300 more a month to pay their current rent. One alternative is to rent out office space, something she is considering.

Hart has been fund-raising in the community. "I've gone door to door and the response has been wonderful," she said.

Safeway is sponsoring the SCWR this year by providing donation cans at each check-out counter starting July 29.

Safeway employees can choose to donate \$1 to \$5 from

their salaries and Manager Tom Rosina said he'd let his employees "dress down" on Fridays if they donate \$5 to the Refuge.

The Burney Lions Club hopes to host a benefit dinner for the Refuge and Hart has collected a variety of donations from merchants and community members to fill four baskets valued at \$300 each.

Tickets for the baskets will be on sale soon and they will be given away in October.

Hart and her husband

retired and moved to this area four years ago. They lived in Monterey area for 23 years where Dottie was an instructor from Monterey Peninsula College.

She also worked in a Regional Occupational Program helping retrain people for employment.

"We love it here and think it's very beautiful," she said. "We love the rivers, lakes and streams and hiking."

Want to know more about caves? How about just exploring them for fun?

The study and exploration of caves is called speleology (SPEE-lee-AH-lah-gee).

Scientists who study caves are called speleologists. They can be experts in different things about caves. For instance, some are geologists. They study how caves are formed. Some are biologists. They study plants and animals that live in caves.

Some people explore and map caves as their hobby. They are called spelunkers or cavers.



Who were the first cave explorers? Well, the cavemen, of course.

Go back some 30,000 years and you will find people were exploring caves. Back then, people sought shelter in caves from the cold, rain and snow. To light their way, they carried torches or stone lamps. Animal fat was burned for fuel.

Today, caves remain mysterious places. We know a lot about what is above the surface, but very little about what is below the surface.

A famous cave scientist was a man named Edouard-Alfred Martel. He lived in France from 1859 to 1938. As a little boy, just 7 years old, Martel loved caves.



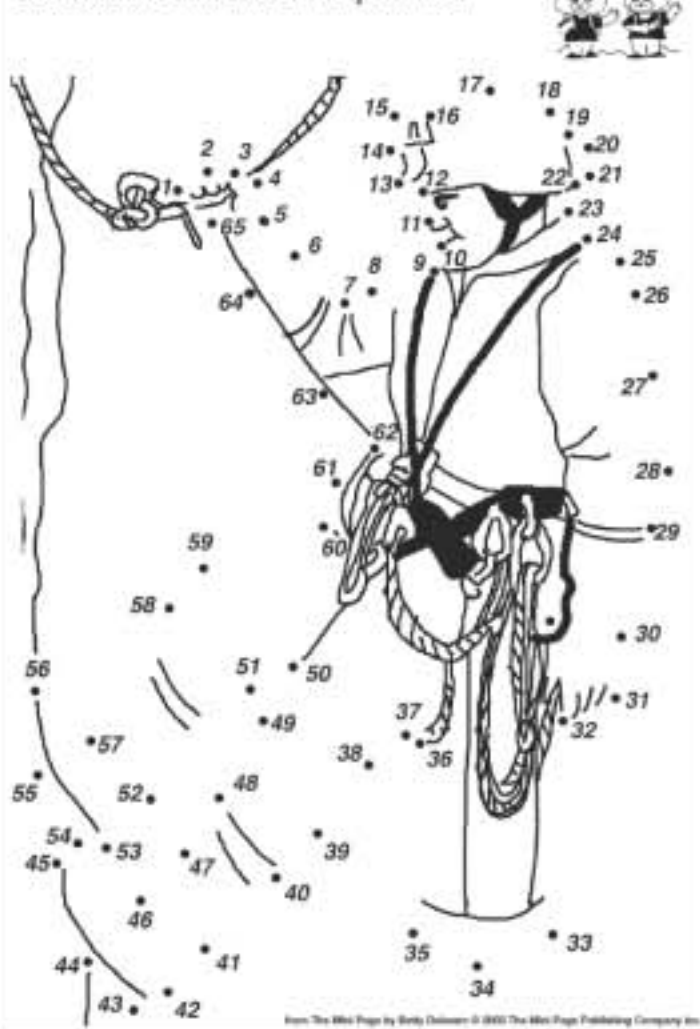
He worked hard to measure caves and took careful notes about what he found in them. He also developed special ways of using ropes and safety equipment to make cave exploring safer.

Martel explored thousands of caves in his lifetime and started the first international society to study them. He is remembered today as the father of speleology.

The tools to use

What do cavers take when they go caving?

They have to take lights and clothing and equipment to keep them safe, dry and warm.

What to wear

1. safety helmet.
2. helmet lamp.

4. boots with a good tread.
5. kneepads.

Another job is to make sure safety rules are followed: no climbing off the trail, no touching of cave formations, and kids staying with their parents.

Paula remembers going into her first caves with her father when she was a young girl.

She finds caves fascinating because there is so much we don't know about them. And she has fun just crawling through them.

The rules to follow

Caves can be dangerous places. You can get lost in the dark. Rocks or boulders could fall on you. If you go into a cave, follow these basic rules.

To protect yourself

1. Never explore caves alone. Go with at least two other companions. Kids should go only with an adult.
2. Tell other people where you are going and when you will return.
3. Always carry three sources of light: a helmet-mounted light, a flashlight and a backup light. Also, take waterproof matches and candles with you.
4. If you get lost, stay where you are until help arrives.
5. Always use common sense.

To protect the cave

1. Don't litter.
2. Don't touch cave formations. It takes hundreds of years for a stalactite to form. If you break one, you have damaged the cave for a long time.

Cave explorers have a motto: "Take only pictures, leave only carefully placed footprints, kill nothing but time."

Stephen Bishop: guide

A self-educated slave, Bishop became well-known at Mammoth Cave in Kentucky as an explorer and guide in the early 1800s. He discovered some of the same routes still used today at the cave. He earned his freedom, but chose to stay at Mammoth.

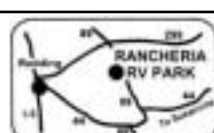

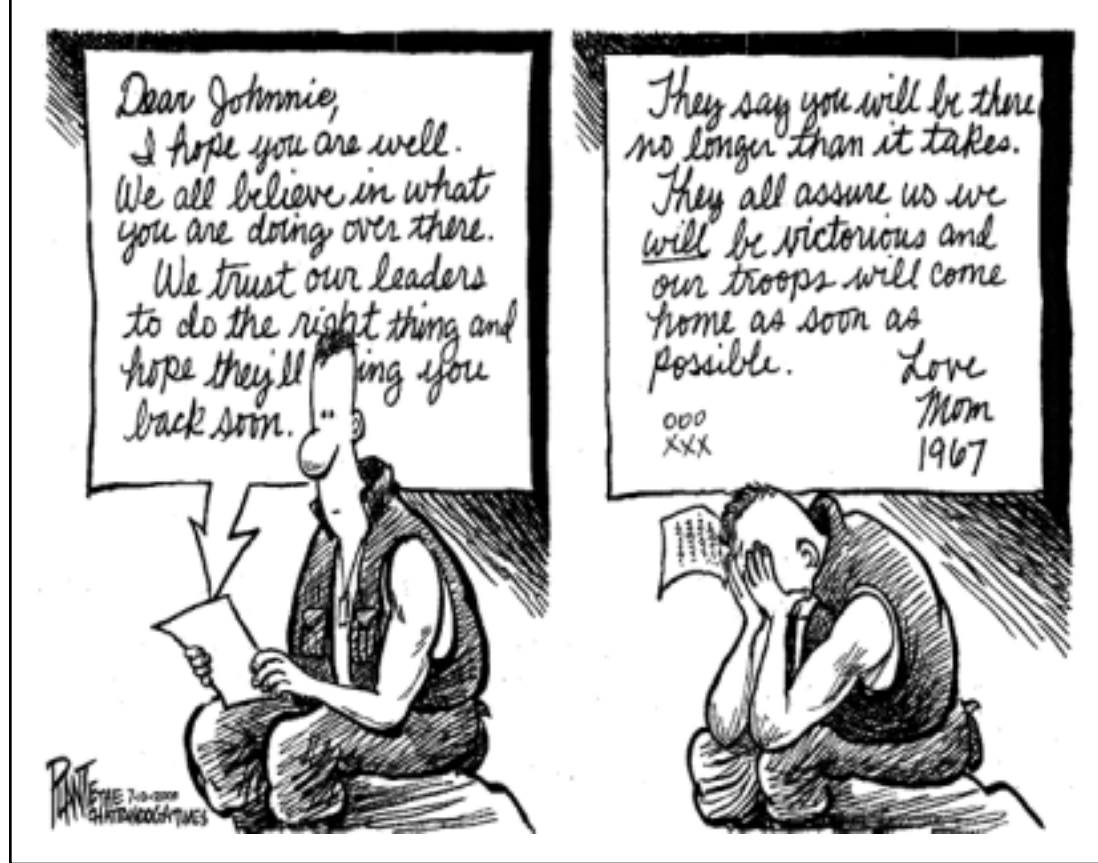

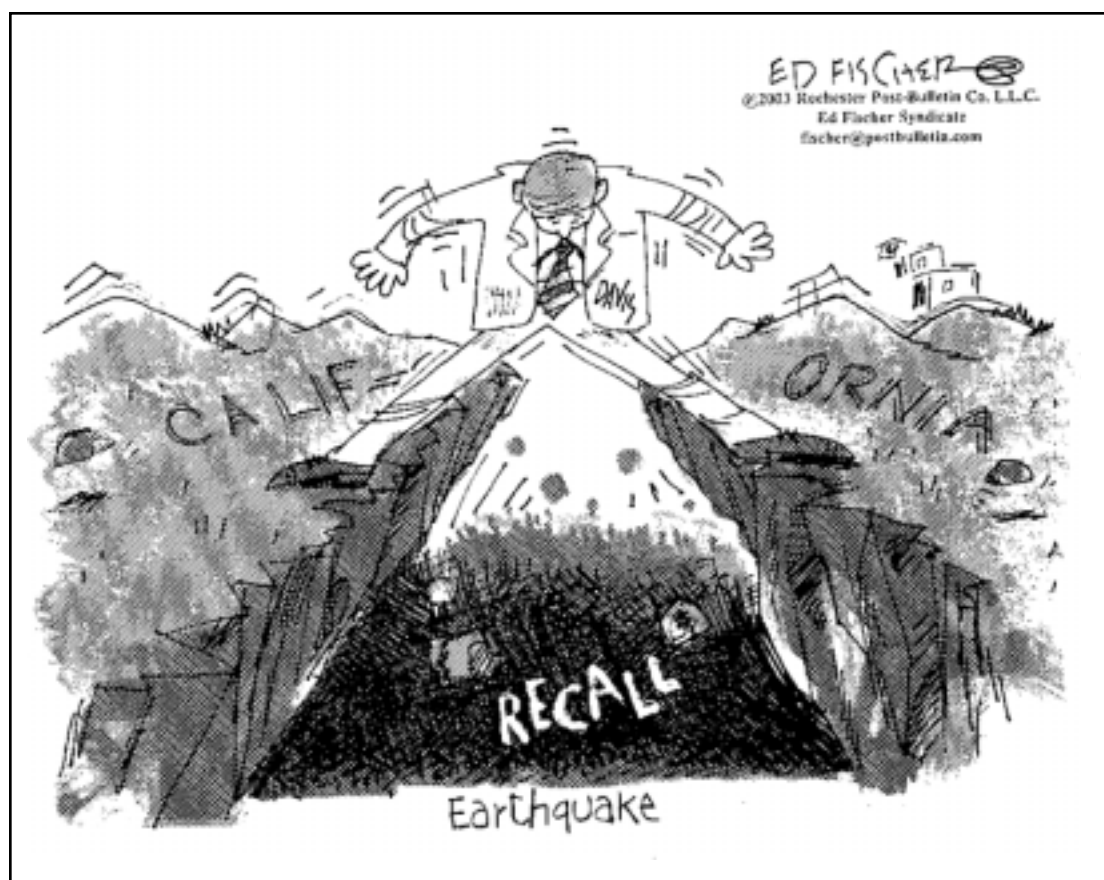
